## Mare Breeding Contract

I hereby agree to breed my mare \_\_\_\_\_ Reg.No: \_\_\_\_\_  
to the stallion LITTLE GUNOLENA, AQHA reg. no: 3'854'570 for the 20\_\_ season at \$ \_\_\_\_\_ Breeding Service Fee  
which includes a Chute Fee of \$ 600.- Included in this Chute Fee is the first shipment of cooled semen. It also covers the first 8  
palpations. After the first 8 palpations a palpation fee will be charged.

Embryo transfer mares: all palpations will be extra

### ALL MARES MUST PAY THE ENTIRE STALLION SERVICE FEE UP FRONT BEFORE THE MARE IS BRED.

All other expenses including board and all vet expenses will be due in full when the mare departs.

1. I agree to the term that each additional shipment of semen will be my responsibility at the following charges: \$250.- for FedEx or UPS service per shipment. \$150.- for the pick-up at Mountain Park Ranch for each pickup. Every order must be paid in full prior to shipment or pickup.
2. If an Equitainer is used for the shipment I agree to return it at my own expense immediately after reception of the semen.
3. It is understood that, should the foal not stand up and nurse, I will be entitled to a return privilege. This guarantee applies only if I notify you within one (1) week from death of the foal. This notice must be accompanied by a statement from a licensed veterinarian. If the mare is to be returned and the owner of the mare fails to deliver her for rebreeding the following year, then any and all fees shall not be refunded.
4. Diligent effort will be made to settle my mare; however, if for any reason she does not settle, this will entitle the mare to one return breeding the following year providing the balance of the stud fee is paid before the mare departs from the ranch. The rebreed is good the following year only. I will not hold the stallion owner or his representatives liable.
5. It is further understood that, should the aforementioned stallion die or become unfit for service, the breeding fee will be returned.
6. A "Breeders Certificate" will be issued upon notification of the birth of the foal.
7. The Mare's Registration Certificate or a photocopy of the front and back of the certificate must be furnished. **All mares must have a Veterinarian Health Certificate within 30 days and current Coggins within 6 months.**
8. Mares that are not halter-broken will not be accepted. Aged mares that have been barren for three or more years will not be accepted.
9. I understand and agree that neither MPR Mountain Park Ranch Inc. (subsequently MPR) nor his representatives will be responsible for accidents, sickness or death to my mare or foal; however MPR and its representatives will take all reasonable precautions in their care and supervision.
10. When MPR's representative signs and returns one copy of this contract to me it will then be a binding contract on both parties subject to the above terms and conditions. This contract is not transferable without written permission of MPR.
